**Licensing:** The soon to be opened Starbucks in the Park Plaza presented at the licensing subcommittee

meeting. They have asked for 8-10 outside seats on the Arlington Street side of the building.

A motion was made and seconded not to oppose the request for outside seating. The motion passed

on a vote.

As a community gesture, the store is offering the BVNA free coffee for its meetings and the clean-

up.

**City Srvcs.:** Sarah asked that BVNA confirm its vote to change the meter spaces on Arlington between Isabella and Cortes to resident-only spaces. After a discussion, a motion was made and seconded to request

the city remove the meters at this location. The motion passed on a vote.

An update was provided on the proposal to reverse the direction of Isabella Street. The petition is

being circulated and the developer of 25-29 Isabella Street is completing the traffic study required

by the city.
